## RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

### DISCLAIMER CLAUSE

ANGELS' ARMS, including its officers, directors, employees, volunteers, members, representatives, and Sponsors of Bar Bounce 2017 (hereafter referred to as "the Organization") is not responsible for any injury, loss or damage of any kind sustained by any person while participating in Bar Bounce 2017 (hereafter referred to as "the Event"), including injury, loss or damage which might be caused by the negligence of the Organization.

### DESCRIPTION OF RISKS

In consideration of my participation in the Event, I acknowledge that I am aware of the possible risks, dangers and hazards associated with my participation in the Event, (including the possible **risk of severe or fatal injury** to myself or others). These risks include but are not limited to the following:

- a) the risks associated with travel to and from location(s) to be visited during the Event, including transportation provided by commercial, private and/or public motor vehicles;
- b) intoxication and/or alcohol poisoning from the alcohol I consume whether voluntarily or through coercion;
- c) the possibility of bodily injury (broken bones and soft tissue damage) including dental damages from falling down, injuries incurred while getting on or off (in or out of) the mode of transportation being used for the event, being knocked down or being involved in a physical confrontation whether caused by myself or someone else;
- d) the risks associated with returning to my residence.

### INDEMNIFICATION AND RELEASE OF LIABILITY

In return for the Organization allowing me to voluntarily participate in the Event and related activities, I agree:

1. **TO ASSUME AND ACCEPT ALL RISKS** arising out of, associated with or related to my participating in the Event, even though such risks may have been caused by the negligence of the Organization;
2. **TO BE SOLELY RESPONSIBLE FOR ANY INJURY, LOSS OR DAMAGE** which I might sustain while participating in the Event, even though such injury, loss or damage may have been caused by the negligence of the Organization;
3. **TO HOLD HARMLESS AND INDEMNIFY THE ORGANIZATION:**
  - a) from any and all liability for any damage to the personal property of, or personal injury to, any third party resulting from my participation in the Event and all related activities; and
  - b) from any and all claims, demands, actions and costs which might arise out of my participating in the Event, even though such claims, demands, actions and costs may have been caused by the negligence of the Organization.

I acknowledge that I have read this agreement, that I have executed this agreement voluntarily, and that this agreement is to be binding upon myself, my heirs, executors, administrators and representatives, in the event of my death or incapacity.
